### Introduction

This Cookie Policy explains how Dale's Hideaways ("we", "us", "our") uses cookies and similar technologies to recognise you when you visit our website at [www.daleshideaways.com](http://www.daleshideaways.com) ("Website"). It explains what these technologies are, why we use them, and your rights to control our use of them.

### What are cookies?

Preference cookies enable a website to remember information that changes the way the website behaves or looks, like your preferred language or the region that you are in.
